The attached photo shows the silt fence check dams that were previously keyed in. The silt fence we have been requesting that they key in is along the bottom of the entire slope of Lots 9 and 10 (especially Lot 10). If they could send a photo showing that they have properly keyed-in the silt fence along the bottom of the project, that would be great. I attached a marked up photo showing the check dams (red arrows) where silt fence is properly keyed in, and the silt fence along the bottom of the slope (yellow arrow) where the silt fence was not properly keyed in during my last inspection on January 2, 2020.

I was planning to conduct my next inspection the first week of February since that will be 1 month from my January 2 inspection. Please let me know if you would like me to swing by this week to check on the silt fence status.
