It was nice to see you onsite today. Thank you for taking care to keep the streets clean of track out!

On Lots 9/10

- The silt fence in the southeast corner of Lot 9 is becoming loose, likely due to the recent winds. Please ensure that this is tightened up so that it does not begin to tear or fall down.

On Lot 11

- The silt fence and chain link fence on the south side of the house, next to the riparian area, is falling down. Please repair or replace the fence in this location. This is an ongoing issue and should be addressed ASAP.

I know you have Ernesto coming out this week to assist with BMP repairs. Please ensure that these repairs are addressed no later than the end of the week to ensure that the silt fence is functioning prior to stucco and paint application on Lot 11 in the coming weeks.
