#### **MATERIALS PRESENTED FOR THE HEARING:**

Applicants and members of the public are encouraged to submit materials to staff in advance of a hearing. All materials (including but not limited to models, pictures, videos, etc.) presented by any person speaking on any item on the agenda are considered part of the administrative record for that item, and must be retained by the Design Review Officer until such time as all administrative appeals are exhausted and the time for legal challenge to a decision on the item has passed. If you wish to retain the original of an item, a legible copy must be left with the Design Review Officer. The original or a computer-generated copy of a photograph must be submitted. Five (5) copies of written material should be provided for the Design Review Committee, staff and interested parties.

#### **DECISIONS AND APPEALS PROCESS:**

The Emerald Lake Hills Design Review Officer will make a decision when design review is the only application being considered, or make a recommendation to a different decision maker when additional planning applications are associated with the project (e.g., use permit, grading permit, etc.). Decision rulings for a project are appealable to the Planning Commission. Appeals must be filed no later than ten (10) business days following the decision at the San Mateo County Planning Counter (address listed above). Appeal application forms are available online and at the Planning Counter. The appeal fee is \$616.35 which covers additional public noticing.

Consideration of Design Review recommendation of a major remodel involving a 800 square foot addition to the existing second story and exterior redesign of an existing 2,808 sq. ft. single-family residence, (1,871 sq. ft. with an 937 sq. ft. attached three-car garage) on an 11,200 sq. ft. parcel on at 735 Paradise Way. No significant trees are proposed to be removed. The application requires a Home Improvement Exception (HIE) to allow an additional 250 sq. ft. of floor area. The Design Review Officer will not render a decision but will make a recommendation to the Community Development Director regarding compliance with design review standards. A decision on the HIE will occur after November 7, 2017.

Consideration of Design Review recommendation of a major remodel involving a creation of a new 2,689 sq.ft. lower level and 1,525 sq. ft. covered decks and patios, to an existing 2,965 sq. ft. single-family residence with an attached 595 sq. ft. garage on a 1.48 acre parcel. The application requires a grading permit in the amount of 478 cubic yards of earthwork. No significant trees are proposed to be removed. The Design Review Officer will not render a decision but will make a recommendation to the Community Development Director regarding the project's compliance with the design review standards. A staff-level decision on the grading permit will occur after November 7, 2017.
